INCORPORATION OF LIONS CLUBS IN THE DISTRICT

Have you, as a Lions Club member, ever wondered why your Club became incorporated? Well, the most compelling reason is that

incorporation gives the members of your Club and its office bearers protection against personal liability for the Club's debts.

However, as would be expected, incorporation brings with it a number of responsibilities, known as statutory obligations, which include the preparation and submission of an annual report to Consumer Affairs Victoria (CAV). It is disappointing to note that, even though all Lions Clubs in the District are incorporated and the vast majority of Clubs do indeed submit a report to CAV annually, there are a few Clubs that do not, which is in contravention of their statutory obligations – Club Secretaries please check that your Club is doing the right thing.

Your Lions Club is bound by the provisions of the Standard Form Lions Club Constitution and By-Laws issued by LCI and the provisions of the Associations Incorporation Reform Act 2012. To simplify all of this, in 2013 I prepared the "Lions Club Rules and By-Laws", which combined the provisions of both the Standard Form Lions Club Constitution and By-Laws and those of the 2012 Reform Act in a single document. This document was then approved by CAV and, with the approval of IPDG David Barnes, was distributed to the Lions Clubs in the District around September 2013 with a recommendation that all Clubs adopt the document as their revised rules and by-laws.

Some Clubs have adopted the document, but, unfortunately, it appears that a significant number of Clubs have not yet done so.

Simply put, whatever document your Club used as part of its incorporation process, if it wasn't the "Lions Club Rules and By-Laws", that document no longer reflects the current provisions of both the Standard Form Lions Club Constitution and By-Laws and the 2012 Reform Act, which is unacceptable.

So, now is the time for your Club to adopt the "Lions Club Rules and By-Laws", if it hasn't already done so.

If your Club doesn't have a copy of this document, I would be pleased to forward a copy in Word format, together with a simple step-by-step procedure to enable your Club to adopt it.
